### AIM AND PROGRAMME

The International Summer School on Banking & Capital Markets Law consists of a five-day programme. The first day will take place at Università Cattolica del Sacro Cuore in Milan and then the participants will move to Villa Vigoni at Lake Como where they will spend the following days in a relaxed and constructive atmosphere.

Participants are expected to attend the entire Summer School.

The aim of the Summer School is to provide junior researchers and young professionals in the field with mentoring as well as with exposure to cutting-edge research in banking and capital markets law.

Participants will have the opportunity to present their own research projects (both completed papers and work-in-progress) and to discuss them with leading researchers. These presentations will be key components of the Summer School: participants will be invited to give concise presentations of their work, followed by an in-depth discussion of each contribution among participants and senior scholars.

Participants will also have the opportunity to attend lectures given by high-level speakers, such as senior academics, representatives from EU and national supervisory authorities, the European Commission and practitioners in the field, who will conduct interactive workshops on the most recent topics of banking and financial law, including

- FinTech
- Corporate Governance of financial institutions
- European Banking Union
- Capital Markets Union
- MiFID II
- Market Abuse Regulation
- Brexit
- Sustainable Finance.

In order to ensure a highly interactive environment, the number of participants will be limited to 30.

## ELIGIBILITY

The Summer School is intended for: 1) PhD researchers, post-docs and junior faculty members conducting research in the field of Banking & Capital Markets Law; 2) young professionals who are actively involved in the topics of the Summer School

## COSTS

Participants will be asked to pay a **registration fee of EUR 1000 (VAT included)**. The fee includes full board accommodation (arrive 22nd July 2019 - departure 26th July 2019). Travel expenses are excluded.

Participants belonging to partner universities and the EBI Young Researchers Group (YRG) will be asked to pay a registration fee of **EUR 900 (VAT included)**. A further reduction will be applied when the fee is paid directly by the partner universities.

## APPLICATION

Participants wishing to apply should send the following documents by email to [elvira.dinallo@unicatt.it](mailto:elvira.dinallo@unicatt.it) **within 30th May 2019**:

- a short CV (pdf file)
- a motivation letter
- a research abstract (max 500 words) including a clearly defined topic, research questions and methodology

Applicants who are ready to submit their complete paper can send it together with the documents above. The submission of work-in-progress proposals that describe on-going and promising research are also welcomed, because they will benefit from an open discussion about the main conceptual and methodological problems related to the project. In any case, to allow a fruitful discussion, the complete paper or a detailed and well-developed research proposal must be sent no later than 1st July.

Although preference will be given to those presenting their paper, participants who do not wish to present their research can apply anyhow and are required to submit a short CV and a motivation letter only.

Priority will be given to participants from partner universities and EBI YRG members.

Admitted students will have to pay the registration fee within 10 days from the admission notice to the following bank account:

### SCHOLARSHIPS

8 full scholarships covering the registration fee will be funded by EBI, AEDBF, Intesa S.p.a. (Group IBM), Gattai, Minoli, Agostinelli & Partners Studio legale, LCA Studio legale and ASLA.

Participants, wishing to apply, will have to include their request in their motivation letter.

An academic committee, composed of professors chosen among the Summer School directors, will award the full scholarships after evaluating the submitted documents.
